RULES AND REGULATION

1. ADMISSION AND ALLOTMENT

Mandatory Accommodation:

Hostel accommodation is mandatory for all residents. The hostel is treated as an extension of the institute and observance of rules of the Hostel is compulsory for all the students.

General:

- (A) Hostel rooms/beds will be allotted depending on availability and allotment policy.
- (B) Hostel accommodation will be made available for new admissions only after paying Prescribed deposit.
- (C) Hostel fees once paid will not be refunded in any case.
- (D) Hostel Caution Deposit will be refunded when the student leaves the college after completion of the course, after deducting liable penalties. THE REFUND WILL BE MADE ONLY AGAINST ORIGINAL RECEIPT OF DEPOSIT.
- (E) Fees will have to be paid by the student in advance, at the beginning of each Month the period stipulated by the authority.
- (F) Hostel disciplinary rules will have to be strictly followed by each inmate.
- (G) If hostel fees is not paid in time or delayed without any valid reason and prior permission of the hostel in charge / authority, fine and / or penalty will be imposed as decided by the Management / Dean.
- (H) Students admitted in hostel will not be allowed to leave the hostel in middle of the year during the semester. Permission shall not be granted to leave the hostel except for valid reason. But no refund of hostel fee will be made.
- (I) Management /Dean decision for hostel fees, deposit, refund etc. will be binding & Final.
- (J) Hostel PRFECT will be selected on MERIT or as decided by the hostel-in-charge amongst hostel students to assist the hostel-in-charge in the supervision of hostel and in enforcing discipline. Every hostel INMATE should extend co-operation to them in the act of discharging their duties.

Damage:

- (A) Boarders will be personally and collectively responsible for any LOSS OR DAMAGE to the properties and equipment and other fittings in the COMMON PLACE.
- (B) In case of any DAMAGE to any building, furniture, apparatus for other property of the hostel, the loss caused to the institution shall be recovered EITHER DIRECTLY from the IDENTIFIED persons whenever possible, but if persons who cause the DAMAGE are unknown, the cost of repairing it AS MAY ASSESSED will be distributed EQUALLY among all the student of the hostel/such GROUPS of association as may be responsible.
- (C) The student shall not bring any extra furniture or other fixture in the room. All furniture and fixture in the rooms allotted to the student must be cared properly.
- (D) The student will be required to pay if any item is found damaged or missing from their room due to careless/negligent handling. The student will also be charged/ fined for of the repair of an item that is found to have been willfully damaged or have been damaged on account of misuse or unfair wear and tear.

Energy Conservation:

- (A) Fans, AC, lights must be switched off when the students leave their rooms. Light be switched off POSITIVELY when they go to BED. In case it is noticed that Fans/Lights/A.C. are ON in the locked room a penalty will be imposed for wasting the costly energy sources. Misuse of electricity has to be avoided by all means.
- (B) Use of Computer is permitted for education purpose only. Any kind of misuse in hostel done by Inmate admission will be cancelled.
- (C) Electric bill will have to be paid according to electric Meter.
- (D) Usage of any electrical or electronic appliance in the room above the prescribed capacity is strictly prohibited. If needed it is subject to prior permission of hostel authority.

Room Checking:

The Campus Authority/Hostel Wardens/or any other Officials of the Institutes along with Security Guards may at their discretion inspect/check any room or student's belongings in the presence of the students living there in any time of the day or night.

Personal Possession:

- (A) Vehicle, mobile phone, gold ornaments, cash etc. will be kept by the inmate strictly on his/her own responsibility. For any kind of accidents, theft or damages, the institution will not be responsible. In case a police complaint need to be field, they should do so through proper channel.
- (B) Proper use of the vehicle and proper parking in campus is must. Mishandling of other's vehicle or property will be considered as serious offence and it may lead to punitive action.
- (C) Students are advised NOT TO KEEP valuables in the hostel room. They are advised to deposit EXTRA CASH in the bank or in the post office or any other SAFER place.

Expulsion from Hostel:

The Institute/Campus Authority reserves the right to terminate the temporary/Permanent occupancy of the student for any willful disobedience or defiance of authority, non-observance of hostel rules, causing damage to person or property or indulging in ragging, anti-social, anti-national or undesirable activities. In such cases the deposit shall be forfeited and hostel fee will NOT be refunded. Students recommended for expulsion from the college, will also be expelled from the hostel and fee will not be refunded.

2. Mess and Dining:

Mess:

- (A) Mess Facility is Compulsory, menu is pre-decided, Food will be given as per menu.
- (B) Hostel Fees include Mess Charges.
- (C) TIFFIN from out-side are not allowed in the hostel.
- (D) Only members of the Hostel are permitted to dine in the mess. Outside food/Tiffin (dabbas) are strictly forbidden in the Hostel. Members are expected to inform their Absence/dining out or night out to the Mess Supervisor well in advance, to avoid Wastage of food.

Mess Timing:

Break fast :7:30 a.m. to 10:00 a.m.
Lunch :11:30 a.m. to 02:30 p.m.
High Tea :4:30 p.m. to 06:00 p.m.
Dinner :7:30 p.m. to 10:00 p.m.

3. General Rules:

Disciplinary Rules:

- (A) The student admitted in the hostel must remember that his/her behavior inside and Outside the campus should be befitting to a professional student.
- (B) Student once admitted in the hostel will continue to be a hostel inmate throughout the year. In case a student debarred from the hostel on disciplinary grounds will have to bear the fees for the year.
- (C) The inmate should occupy only the room allotted to him/her by the hostel authority, Change of room by the student without prior permission will not be allowed and will be viewed as serious offence. On the other hand he/she will have to obey any order by the hostel authority in case of reshuffling of the rooms.
Subsequent to issue of “ HOSTEL IDENTITY CARD” each inmate has to produce the card whenever asked by the authority.
- (D) Violation of any rules will make the student liable to disciplinary action including EXPULSION from the hostel.
- (E) Students must remember that the hostel is the HOME of the student in the campus and therefore, he should behave himself in the CAMPUS as well as outside in such a manner as to bring credit to him and the Institution.
- (F) Resident of the hostel is not allowed to take any articles/utensils etc. outside the hostel premises.
- (G) No association or group of students on the basis of regions, casts or creed is permitted, during their stay at the hostel. If any student occupies a room illegally or allows other student/person to stay illegally in the hostel, he will not be permitted to avail hostel facilities during his career as a student in the hostel.
- (H) Whenever students are leaving hostel premises lock their room properly.
- (I) Usage of computer and printer in the hostel room will be allowed with prior permission from Hostel-in-charge. Usage of the above without prior permission will be considered as violation of rule.
- (J) The students are provided with basic amenities like bed, table, chair, cupboard, and all other usual fittings like ceiling fan and 24 hours water supply. Hostel inmates shall be held responsible for the damages to the furniture supplied to them. Writing on benches, tables, chairs, doors, walls, cupboards etc. is strictly prohibited.

- (K) shouting, loud singing, playing and loitering in corridors, Affixing of Photos, wall-paper, indecent posters, stickers on the walls and glass panel, playing cards, musical instruments, audiovisual devices etc. are prohibited. The student or group of student will be liable to disciplinary action.
- (L) The students should be decently dressed when they are out of room.

Hostel Staff:

The student shall behave with the staff and housekeeping staff of the Hostel with due courtesy at all times. Service of the housekeeping staff shall NOT be utilized for private or personal work. No tips in cash or kind should be given to the staff of the Hostel.

4. Strictly Prohibited Activities :

Ragging:

- (A) RAGGING IS A LEGALLY CONZIBLE OFFENCE. RAGGING OF ANY KIND IS A NON-BAILABLE, PUNISHABLE OFFENCE AS PER HON. SUPREME COURT OF INDIA AND INSTRUCTION COANTAINED IN D.O. LETTER NO. F-10-60//88-U, FROM GOVT. OF INDIA. THE OFFENDER'S WILL BE EXPELLED FROM THE HOSTEL AS WELL AS COLLEGE. CRIMINAL CASE ALSO MAY BE FILED AGAINST SUCH OFFENDERS, AT THE DESCRETION OF THE ADMINISTRATION.
- (B) Any act of teasing, miss handling, using abusive words, physical or mental torture and such other type of act, which creates physical or mental tension on another student or a group of students, shall be treated as ragging.
- (C) Being a silent spectator and not reporting/stopping others indulging in ragging is also an offence. Students should report any such incident immediately to any member of the Anti-Ragging Committee/Warden/Hostel Manager/Security Personnel/Dean directly at any time of the day/night.

Gambling:

No gambling of any kind whatsoever shall be allowed on the premises of the hostel. Any violation of this Rule will invite action as per law of the land, in addition to expulsion from the institute.

Misuse of Internet and Online Social Media:

Any act uploading derogatory remarks or image ridiculing a person in eyes of other against the Institute or any other person or organization will invite disciplinary action. Student should strictly refrain from indulging in any act of violating the code of internet use.

Political or Communal Activity:

The student shall not indulge in any political or communal activity which is detrimental to the Law and order and/or against the Government. Student shall not carry on any propaganda or publicity of any nature whatsoever in respect of any political or communal matters.

Information to Media:

The student shall take prior written permission of the Warden/Campus Authority before giving any information or interview regarding Hostel to any member of the Press, Print Media, Radio, Television or any other media or before making any speech containing any information regarding the Hostel.

Firearms:

Any type of storage or possession of firearm, ammunition, explosive and inflammable goods on the premises of the hostel is strictly prohibited. Violation of the rule will lead to expulsion from hostel and institute.

5. ABSENCE FROM THE HOSTEL:

All the hostel students will have to obtain prior permission to leave the head quarter; they must have to apply well in advance stating the reasons and the address & phone no. of the destination. Those remaining absent for more than five days without information shall be deemed to be missing and parent /guardian and even police may be intimated.

6. ALCOHOL/DRUGS/SMOKING:

The student shall not bring, store, possess, consume and/or drink any alcohol/intoxicating drink, drug or substance of any kind what so ever and/or smoke in the room and/or any part of premises. The same shall apply to visitors also. An occurrence of such behavior shall invite strict disciplinary action leading to expulsion from Hostel, rustication from the Institute and action as per law of land.

7. VISITORS:

- (A) Parent, guardian or relatives will not be allowed to stay in the hostel in any case.
- (B) Any hostel student harboring any UNAUTHORISED ELEMENTS or any person, will be EXPELLED from the hostel.
- (C) Visitors will be permitted to enter hostel Premises after obtaining visitor's Pass at the gate.
- (D) Visitor will not be permitted to go to room of students.

8. INSPECTION:

The room and cupboard of any of the inmates can be inspected at any time by the hostel in charge or any authorized person. Under extra ordinary circumstances the authority will be liberty to check the bags and baggage of any inmates.

9. CLEANLINES:

- (A) The hostel occupants should keep their rooms neat and tidy.
- (B) It is the responsibility of room inmates to discard the wastages of their rooms in the Common dustbins.
- (C) The hostel occupants should maintain the hostel premises neat and clean.
- (D) The hostel occupants are prohibited from writing any slogans or any writings, Drawings, on the hostel walls and rooms.

10. MODIFICATION OF RULES AND REGULATIONS:

- (A) THE MANAGEMENT AND THE APPROPRIATE AUTHORITY RESERVE THE RIGHT TO MODIFY ANY OF THE ABOVE RULES OR TO INSERT NEW RULES FROM TIME TO TIME. THE MODIFIED RULESWILL BE STRICTLY ABIDED BY ALL INMATES.
- (B) The Dean has to the right to admit/cancel room allotment and also frame new Rules/amend existing rules from time to time necessary to maintain peaceful, secured & healthy atmosphere in hostel premises.
